Registration

- Registration is open to members of the speech and language therapy profession, both IASLT members and non-members of IASLT.
- Registration will open early February 2026.
- Registration will close on 7th May 2026 (or earlier in the event that all spaces have been filled). IASLT reserves the right to withdraw a place from a registrant if they do not meet the required criteria.
- All attendees, in particular, speakers and presenters are encouraged to register within the Early Bird registration window which will run from early February to mid-March 2026.
- Once the early bird registration window closes, there will be no further opportunity to register at this reduced rate. No exceptions will be available.
- Registrations will only be accepted through the ex-Ordo conference platform. Attendees are encouraged to familiarise themselves with this platform and all conference-related communications will be sent to the email address provided at registration via the Ex Ordo platform.
- Information that you provide at the time of registration is used solely for the purposes of administering your participation in this event, and for event planning. This may include information about the event's content, logistics, payment, updates and additional information

- Conference tickets are issued in the attendee's name and are non-transferable.

Cancellation Policy

If an attendee needs to cancel their reservation, the following terms apply:

All cancellations must be submitted by email to **kathleencpdadmin@iaslt.ie**. Cancellations sent to other email addresses or suppliers will not be accepted.

- Acknowledgement of the attendee's cancellation request will be sent by email to the attendee within 5-7 working days.
- All refunds will be processed thereafter and will be subject to the following refund schedule.

IASLT reserves the right to postpone or cancel this event in the following circumstances:

- The hotel venue may cancel the event.
- Extreme weather conditions
- Issues related to registration/ logistics/ other
- Other exceptional circumstances beyond the control of IASLT.

In the event of an extreme weather warning please note that IASLT follows Met Éireann weather warnings in relation to event safety and scheduling.

- **Red Warning:** The conference will be postponed for the duration of the warning.
- **Orange Warning:** Conditions will be monitored closely. Attendees are advised to use their discretion when travelling.
